

**REGULATIONS FOR HACKNEY CARRIAGES
IN THE CITY OF SALEM.**

Adopted Jan. 31, 1881, by Board of Aldermen.

ORDERED. That, until otherwise ordered, the price or rates of fare, to be taken by, or paid to, the owner, driver, or other person having charge of any licensed hackney carriage, except omnibuses and barges, shall be as follows:

SECTION 1. For the conveyance, from one place to another within the limits of that part of the city, lying and being within the following described boundaries, viz: Commencing at the junction of Essex and Webb streets, thence running southerly through Webb street to Salem Harbor, thence westerly by said harbor to Union street bridge, thence easterly and southerly by said harbor to Ocean Avenue, thence by Ocean Avenue to the track of the Eastern Railroad Co., thence northerly by said track to Margin street, thence southerly and westerly by Margin street and the Mill Pond to the southern end of Hathorne street; thence westerly by the eastern line of the Great Pastures to Highland Avenue, thence, by Essex, Boston, Grove, Mason, Barr, School and Orne streets to Walter street; thence through Walter street to the eastern end thereof, and continuing on the same course to North river, thence westerly by said river to the bridge on North street; thence easterly by the southern line of North River to the northern end of March street; thence by March, Bridge and Osgood streets to Collins Cove; thence westerly by Collins Cove to Webb street; thence southerly through Webb street to the point begun at; of one or more adult passengers, twenty-five cents each.

SECT. 2. For one or more adult passengers from any place in the city within said limits to any place in the city beyond said limits, but within Block-house square, the junction of Lafayette street and Lynn Road, the Glue Works on Highland Avenue, Prospect, Varney, Rawlins, Watson, Grove, Mason, Myrtle, School and Northend streets, Liberty Hill Road, Appleton and Orne streets, and Beverly Bridge, or vice versa; thirty-five cents each.

SECT. 3. For one or more adult passengers from one extreme to another extreme, of the limits described in the second section, fifty cents each.

SECT. 4. From Washington street, the depots, or any place in the city east of Washington street, and between North and South Rivers to the Willows, Juniper or Winter Island, or vice versa, for one adult passenger, seventy-five cents; or two adult passengers, fifty cents each; for

three or more adult passengers, thirty-five cents each.

From any place in the city beyond the limits hereinbefore stated in this section, but within Ocean Avenue, Boston, Grove, Mason, School and Orne streets, to the Willows, Juniper or Winter Island, or vice versa, for one adult passenger, one dollar; for two or more adult passengers, fifty cents each.

SECT. 5. From any place within the limits mentioned in Section One, to Harmony Grove, for one adult passenger, seventy-five cents; for two adult passengers, fifty cents each; for three or more adult passengers, thirty-five cents each. For returning therefrom with same passengers and without delay, fifty cents; whether for one or more passengers.

SECT. 6. For the conveyance of persons to any place not hereinbefore specified, and for funerals, special reasonable rates may be charged.

SECT. 7. The charge for hackney carriages drawn by two horses, when hired by the hour, shall be one dollar and one-half a dollar for each hour, and when drawn by one horse, one dollar for each hour; and for parts of hours after the first hour, a proportional part of the rate for one hour shall be charged.

SECT. 8. For children under six years of age, with an adult, no charge will be made. For children between six and twelve years of age when accompanied by an adult, the fare shall be half the price charged for an adult, and when not accompanied by an adult, full fare may be charged.

SECT. 9. Between the hours of ten o'clock at night and half past six o'clock in the morning, double the above established rates may be charged.

SECT. 10. No charge shall be made for one trunk, and the valise, carpet-bags, portmanteaus, bundles and baskets, of each passenger, but for each additional trunk, more than one, fifteen cents may be charged; and the owner or driver of any hackney carriage, shall not be required to take or deposit the baggage of any passenger, except from or in the hall or vestibule, of any residence or building in the city.

SECT. 11. When any street is mentioned in this order as the boundary of any limit, both sides of the street shall be deemed to be, and is included, within such limit.

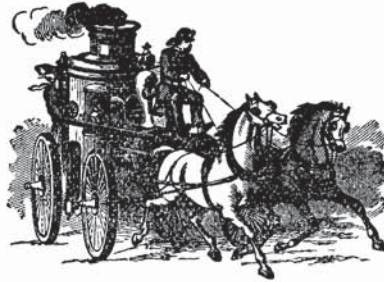

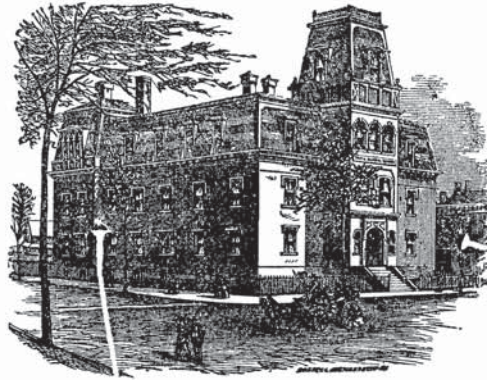

1. AMERICAN ASSOCIATION FOR THE ADVANCEMENT OF SCIENCE. This association dates its origin to 1840, when, on the 2d of April of that year, some eighteen gentlemen, principally connected with the several State Geological Surveys then in progress, met in Philadelphia and organized under the name of "The Association of American Geologists." At the meeting in Boston, in 1842, it was decided to enlarge the object so as to include the collateral branches, and the name to that of "The Association of American Geologists and Naturalists." In 1847, the objects were still further enlarged so as to include all departments of science. A new organization was effected under the present name, and the first meeting was held at Philadelphia, Sept. 20, 1848. This association is republican in its organization and migratory in its visits, meetings having been held in various cities of the Union and Canada annually, except during the years 1861-1865, when they were suspended in consequence of the unsettled condition of the country. A volume of proceedings has been printed for each of these meetings. President, Albert B. Prescott of Ann Arbor, Mich.; Permanent Secretary, F. W. Putnam of Cam-

bridge; General Secretary, Harvey W. Wiley of Washington, D. C. The office of the Permanent Secretary is over the Mercantile Bank, 11 Central street, Salem.

2. ASSOCIATION FOR THE RELIEF OF AGED AND DESTITUTE WOMEN IN SALEM. Organized April 4, 1860. 4. **CITY ORPHAN ASYLUM OF SALEM**, No. 89 Lafayette street. Organized 1866. Conducted by twelve Sisters of Charity. Lady Superior, Sister Brazeau. This institution provides a home for orphan boys and girls, who receive a due amount of education in the common branches of learning.

5. **ESSEX INSTITUTE**. This institution was formed by the union of the Essex Historical and Essex County Natural History Societies, in February, 1848. The former Society was incorporated in 1821, the latter in 1836. In February, 1870, an act was passed enlarging the powers of the Institute so as to include among its objects, the promotion of the arts, science and literature, in addition to those of the original societies. Its library contains about 55,000 volumes bound, and about 150,000 pamphlets, exclusive of duplicates, and embracing all departments of literature. Its museum contains a large collection of antiquarian and historical relics, paintings, engravings, medals, coins, paper currency, &c. The scientific portion is deposited in the Museum of the Peabody Academy of Science. At the time of its removal, the collection contained over 125,000 specimens in the departments of Ethnology, Zoology, Botany, Mineralogy, and Geology, scientifically arranged, and in good part labelled and catalogued. Its publications are, the "Proceedings of the Essex Institute," 6 vols.; "The Naturalist," vol. 1 (afterwards transferred to the Peabody Academy of Science); "Bulletin of the Essex Institute," 22 vols., 8 vo.; "Historical Collections of the Essex Institute," 26 vols., 8 vo. The Historical Collections and Bulletin are regularly issued. Field meetings are held in different parts of the county for scientific and historical investigation and discussion. Evening meetings for the same purpose are regularly held during the winter, at the rooms of the Institute. The Institute also gives courses of scientific and other lectures, and series of concerts during the

winter months, and Horticultural and Art exhibitions during the Spring, Summer and Autumn months. The building next east of Plummer Hall, built by the late Tucker Daland, has been purchased by the Essex Institute, and has been remodelled and arranged to accommodate its library and collections. It also occupies the first floor of Plummer Hall, in which is deposited a portion of its library, and where the lectures, meetings and exhibitions are held, so called in honor of Ernestus Augustus Plummer, whose sister, Miss Caroline Plummer, cherishing his memory, and directing that her gift should be recorded in his name, bequeathed to the proprietors of the Salem Athenæum the sum of \$30,000, to be expended in the erection of a suitable building for scientific and literary purposes. 7. **PEABODY ACADEMY OF SCIENCE**. The "Trustees of the Peabody Academy of Science" organized in 1868, having received funds by gift in 1867 from George Peabody, of London, by birth a son of Essex County, for the "Promotion of Science and Useful Knowledge in the County of Essex."

Under the instrument of trust, East India Marine Hall (erected in 1824) was purchased and refitted, and the Museum of the East India Marine Society and the Natural History Collections of the Essex Institute (begun in 1834) received by the trustees as permanent deposits were placed therein. To this foundation have been added many valuable collections since received by the trustees. A new exhibition hall was opened in 1889.

The arrangement of the Museum is *educational*, and not merely for the purpose of exhibiting curiosities. It is especially designed to aid the teachers of the county in connection with school work.

The collections may be summarized as follows:

1. A collection of the animals and minerals of Essex County, arranged in the cases at the northern end of the first hall. A collection of woods of the trees of Essex County, and one of the pre-historic relics of the county, in the gallery cases.

A large collection of the dried plants of the county, in cabinets, in the lower rooms, may be consulted by students upon application at the office.

II. A synoptical collection illustrating the animal kingdom, from the lowest to the highest forms, arranged according to the text-books in common use in our schools and colleges. This collection is at the southern end of the hall. Letters upon the cases indicate the order in which it should be examined.

III. A type collection of minerals illustrating the edition of Dana's Mineralogy, used in our schools, arranged in the central gallery case.

IV. A collection of objects illustrating the dress, religious customs, implements of war and of domestic use, and objects of art of the native races of China, Japan, India, Korea, Africa, Polynesia, North and South America, etc., arranged in the new east hall. This collection originated in 1799 with the formation of the East India Marine Society, and has had an uninterrupted existence since that date, and was greatly increased in 1868 by the specimens received from the Essex Institute. Large additions to this collection have since been made by the Academy trustees.

V. An historical collection of portraits of prominent Salem merchants, members and officers of the East India Marine Society, together with many interesting relics connected with the early social character of that institution, and models and pictures of Salem merchant vessels. These are preserved in the new east hall, and form an interesting memorial of the commercial history of Salem.

The Academy has published two volumes of memoirs and annual reports; it has conducted classes in botany, mineralogy and zoölogy, and for several years held a summer school of biology. Lectures upon subjects connected with natural history and ethnology are given annually in Academy Hall, a new audience room opened by the trustees in February, 1886.

The average number of visitors to the Museum has been over 43,000 annually during the past five years.

The Museum is open *free* to the public, every week-day from 9 A. M. to 5 o'clock P. M., and Sundays from 2 to 5 P. M.

The large addition made to East India Marine Hall, for the purpose of increasing the Museum accommodations, has on the lower floor a fine lecture hall, known as Academy Hall. It has a seating capacity of 350, is centrally located, comfortably seated, well ventilated, and is in every respect a first class audience room. The hall is used for lectures by the Academy, and is rented for concerts, lectures and readings.

The offices of the Director and Treasurer are on the lower floor of E. I. M. Hall, rear rooms.

8. PLUMMER FARM SCHOOL OF REFORM FOR BOYS. This school was founded by the bequest of Miss Caroline Plummer. It is a school of reform for boys in the city of Salem. The amount of the bequest was \$25,000. Present fund \$50,000. Incorporated May 21, 1855. Building erected in 1870, and the school was opened September 23, 1870. President, William I. Bowditch; Treasurer and Secretary, Gilbert L. Streeter; Superintendent, C. A. Johnson; Assistant Superintendent, C. F. Higgins; Matron and housekeeper, Mrs. C. A. Johnson; Teacher, Harriet R. Hovey; Trustees, William I. Bowditch, Gilbert L. Streeter, Francis Cox, William G. Webb, James Dugan, William H. Jelly, James B. Curwen, George B. Loring, Edmund B. Willson, T. Frank Hunt. A generous bequest of \$35,000 was left to the school by the will of the late Capt. John Bertram. Number of boys in the school, 30.

9. SALEM ATHENÆUM was incorporated in March, 1810. Its conception was suggested by the Boston Athenæum, organized some three years earlier. The characters of the two institutions are in many respects similar, the leading objects of both being the promotion of literature, the arts, and sciences. The founders of the Salem Athenæum were actuated by high motives, and laid a broad basis for future operations, commencing at first with a library, and trusting to the future for the further extension of their views and plans. To this end they purchased the social and philosophical libraries. The former was organized in 1761; the latter in 1781. The athenæum rooms in Central building, Market (now Central) street, were opened to the proprietors on Wednesday, July 11, 1810, with a goodly collection of books upon the shelves, duly arranged and properly classified. In April, 1815, the library was removed to rooms in Essex place; in 1825, to rooms over the Salem Bank; in 1841, to Lawrence place, and in 1857, to Plummer Hall, the present resting place for this valuable and increasing collection of books. The present number of volumes, about 24,500. Miss Caroline Plummer, daughter of Dr. Joshua and Olive (Lyman) Plummer, born Jan. 13, 1783, and died at Salem, May 15, 1854, bequeathed to the proprietors of the athenæum \$30,000, for the purchasing of

12. SALEM EAST INDIA MARINE SOCIETY. Founded in October, 1799. Incorporated in 1801. Membership restricted "to persons who have actually navigated the seas beyond the Cape of Good Hope or Cape Horn." Its chief objects: 1st, to assist the widows and children of deceased members, who may need it, from the funds of the Society; 2nd, to collect such facts and observations as tend to the improvement and security of navigation; 3rd, to form a museum of natural and artificial curiosities, particularly such as are to be found beyond the Cape of Good Hope and Cape Horn. The collections formed were first deposited in the building on the corner of Essex and Washington streets. In 1804 they were removed to the Salem Bank Building, on the site of Downing's Block, and in 1825

to the East India Marine Hall, erected for the accommodation of this valuable collection. In 1867 the building was sold to the Trustees of the Peabody Academy of Science, and the Museum was placed in the hands of the Academy as a permanent deposit. Although no longer conducting the Museum, or making nautical observations, the charitable objects of the society are fully carried out through the means of a fund of considerable amount in possession of the society. Meetings are held quarterly at E. I. Marine Hall. Officers elected annually on first Wednesday in January. President, William G. Webb; Secretary, Nathan A. Bachelder; Treasurer, Nathan H. Millett; Committee, Edward D. Ropes, Wm. H. Jelly, Lewis F. Miller.

13. THE SALEM FRATERNITY. On the 7th of February, 1869, Mr. Alfred Stone, of Providence, formerly a resident of Salem, by invitation addressed a meeting at the East Church, explaining the working of the Providence Union. The next evening a few persons came together, in the parlors of Benjamin H. Silsbee, Esq., to confer upon the matter further. Other meetings followed at the same place, and resulted in the formation of the *Salem Fraternity*; object, "to provide evening instruction and amusement" for such of our population as, "being confined to their work during the day, need recreation at the close of their labors." On the evening of the 21st of April, 1869, the western range of rooms on the second floor of Downing's Block, 175 Essex street, was opened for the purpose, from front to rear. The place was well chosen, central, accessible, attractive in its principal rooms, while the thoroughfare of the Essex st. promenaders led directly past its door. *The Amusement Room*.—The numbers in attendance fluctuates with the season, and with the attractions outside. In the warm weather and short evenings a few only will appear. During the long winter evenings, especially if cold and stormy, this comfortable room is much prized. The average attendance in 1875 was 200; in 1876 was 230. The average of July 1876, was 85; December of the same year, 481. *The Library*.—It began with a few shelves of books, miscellaneous and unselected, in a small, back room. There are now 4221 volumes in the library; 500 for reference only. The takers of books number 1107. This library has been gathered by gift wholly. It was the first free library in Salem. Its large number of readers shows an active circulation. *The Reading Room* is supplied with the Salem papers by the favor of the publishers, and from some of their offices come, besides, many of their most desirable exchanges; several daily and weekly newspapers, pictorial weeklies, religious, scientific, and literary periodicals, find their

way to the tables at a very small outlay of money. Seven magazines and twenty-eight papers are regularly received. *Women's Room*.—On the first of Jan., 1879, a room was set apart for women to meet in for reading, conversation and possibly for industrial instruction, and for an employment reference room. In 1875 the Fraternity became incorporated under the Statutes of Massachusetts. A training school for nurses is connected with the hospital, its object being to supply Salem and vicinity with educated nurses. The time required for the education of a nurse is two years, at the end of which diplomas are given to those pupils who have fulfilled all the requirements. George Z. Goodell, F. S. Atwood and B. R. 15. SALEM LYCEUM. Organized Jan. 18, 1830. Lyceum hall erected in 1831. The purchase of a ticket to the annual course of lectures and signing the By-Laws makes a person a member of the corporation, and the price of a ticket has never been more than one dollar. President, George B. Loring; Vice President, N. J. Holden; Rec. and Cor. Secretary,

Annual courses of lectures have been delivered before the Lyceum without interruption since 1830, and it is the oldest institution of the kind in the country with perhaps one exception.

16. SALEM PUBLIC LIBRARY. On the first of December, 1887, the heirs of Capt. John Bertram offered to the city his late residence on Essex street to be used for the purpose of establishing a Public Library. On the twenty-seventh of December, 1887, the City accepted the gift and instructed its committee to petition the Legislature for authority to issue bonds to the amount of \$25,000 for the use of the library. The library was opened to the public for the delivery of books, July 8, 1889. By the provisions of the deed of gift the management of the library is vested in a board of seven trustees, six to be elected for life by the City Council, and the Mayor of the city for the time being, to be the remaining member, *ex-officio*, and chairman of the board. The City Council elected the following named gentlemen as trustees for life: Geo. R. Emmerton, James A. Emmerton, Nathaniel A. Horton, Thomas F. Hunt, Chas. S. Osgood, Geo. W. Williams, and these gentlemen with the Mayor constituted the first Board of Trustees. Mr. George R. Emmerton and Dr. James A. Emmerton having died since their election, the vacancies have been filled by the election of David Pingree and Jeremiah T. Mahoney. Organization of the Board: Robert S. Rantoul, Chairman; Charles S. Osgood, Secretary; George W. Williams, Treasurer; Gardner M. Jones, Librarian. The library is open every day for the delivery of books (Sundays and legal holidays excepted) from 9 A. M. to 8 P. M., on Saturday until 9 P. M. The reading room is open every week day from 9 A. M. to 10 P. M., and on Sunday from 2 P. M. to 8 P. M.

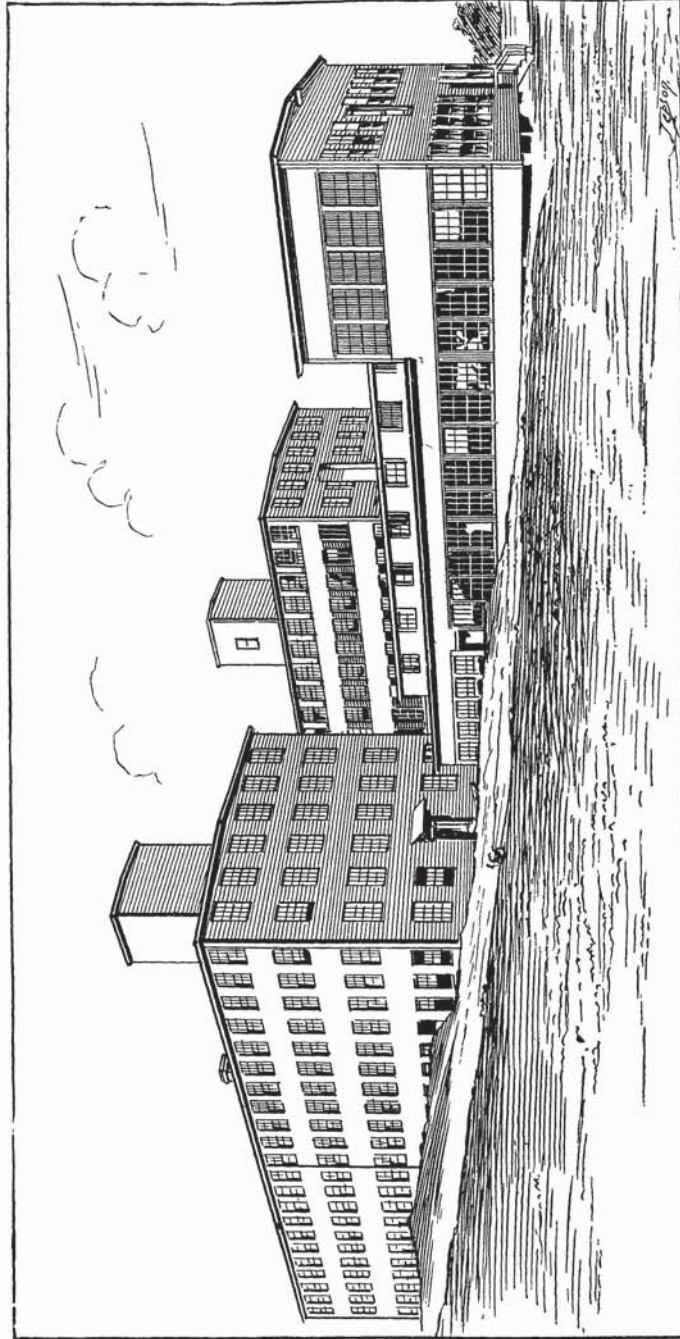

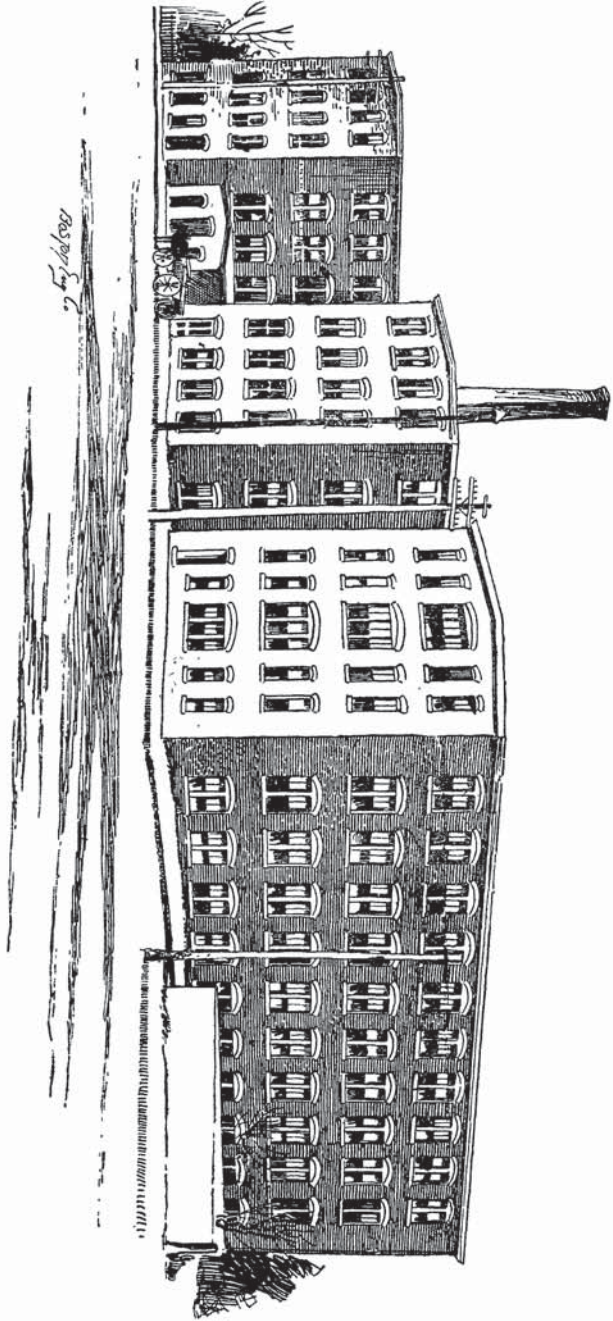

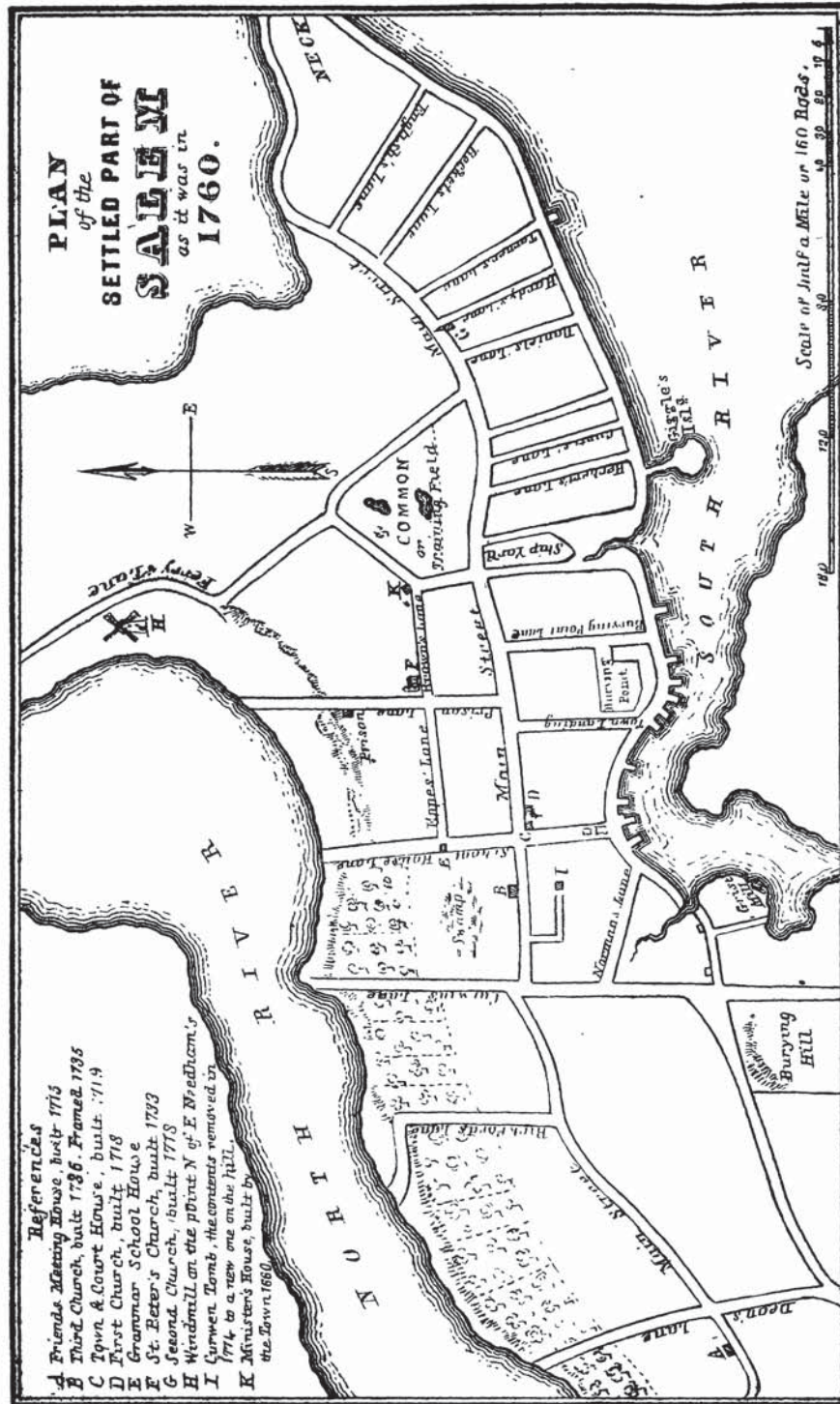


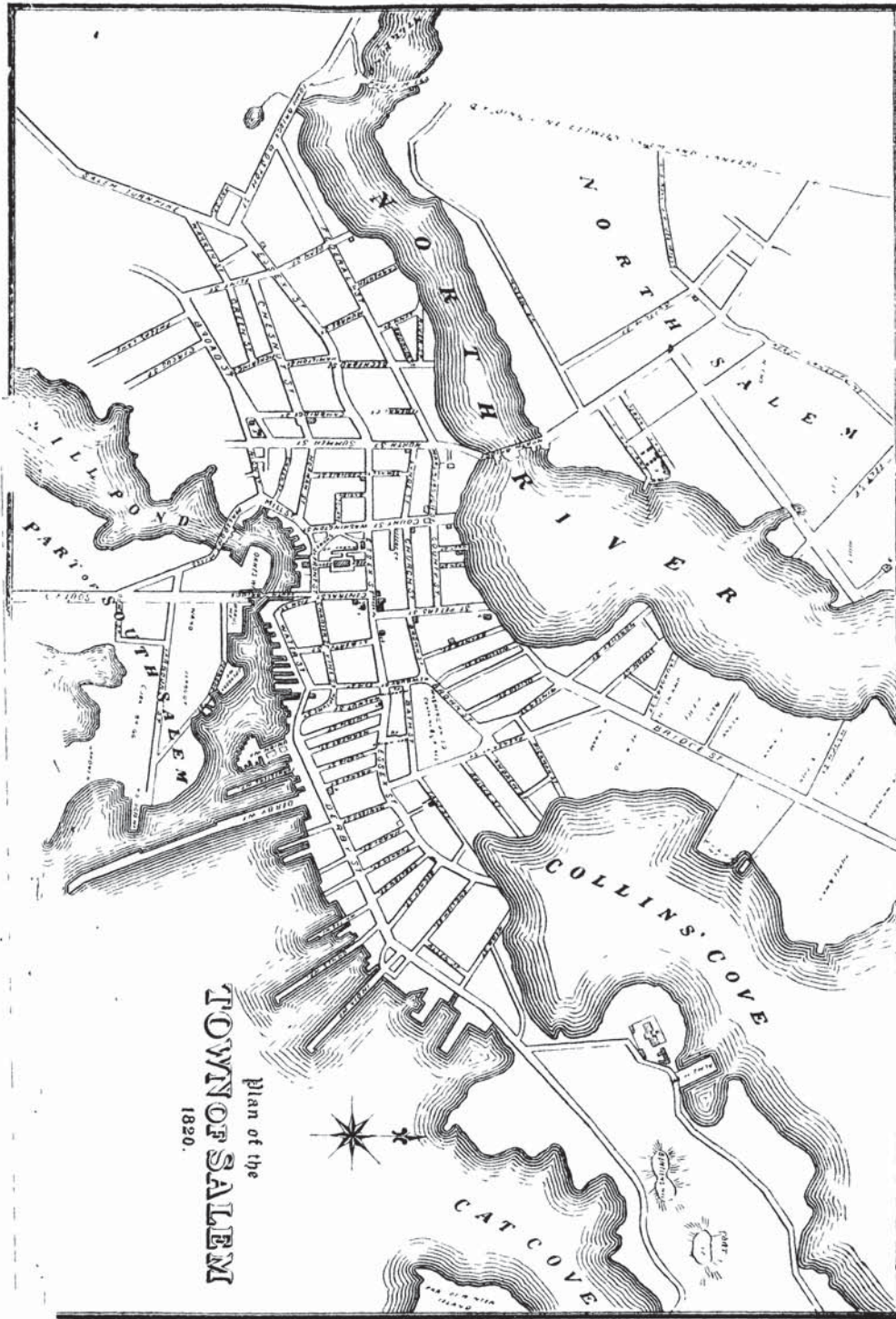


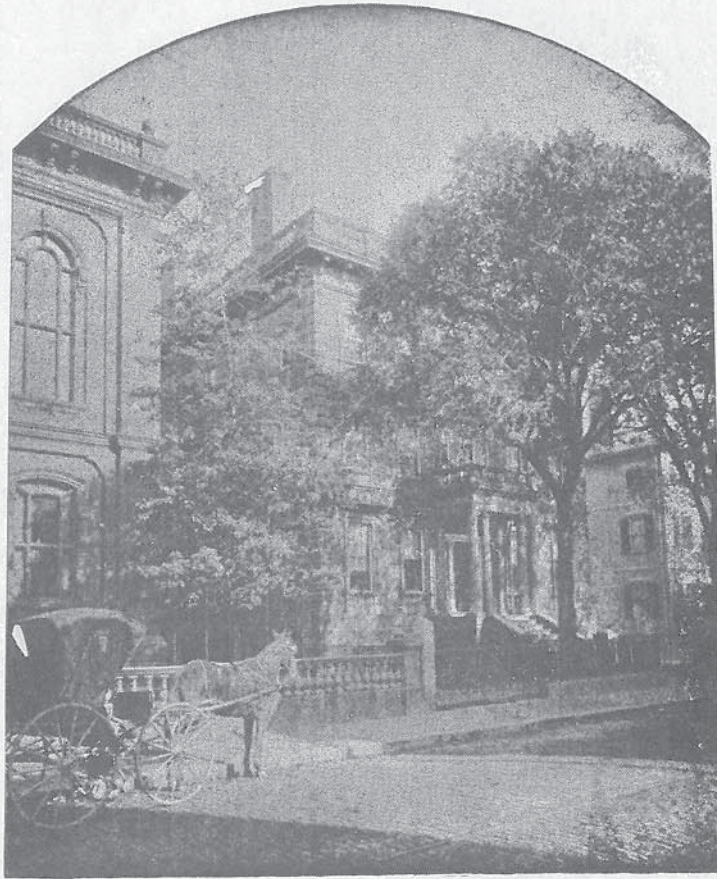

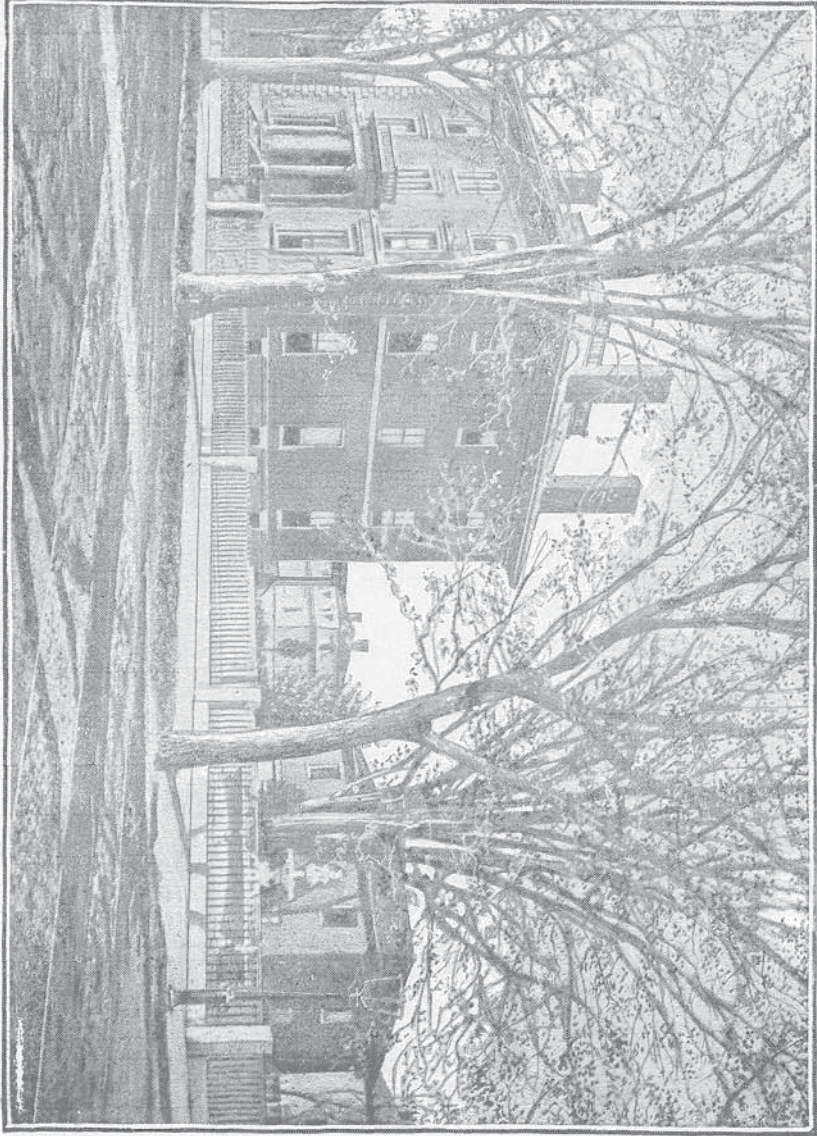
