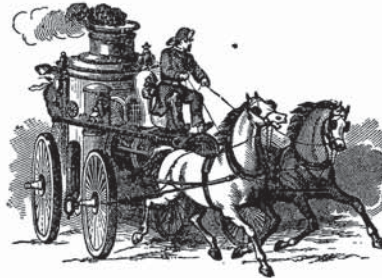

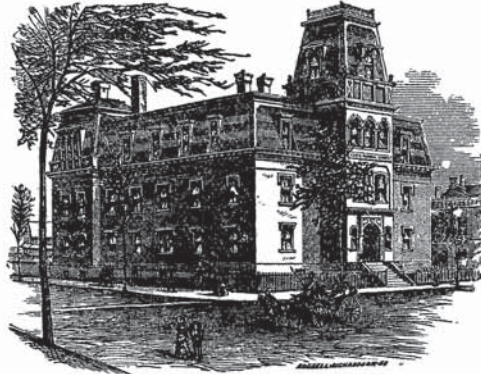

1. AMERICAN ASSOCIATION FOR THE ADVANCEMENT OF SCIENCE. This association dates its origin to 1840, when on the 2d of April of that year, some eighteen gentlemen, principally connected with the several State Geological Surveys then in progress, met in Philadelphia and organized under the name of "The Association of American Geologists." At the meeting in Boston, in 1842, it was decided to enlarge the object so as to include the collateral branches, and the name to that of "The Association of American Geologists and Naturalists." In 1847, the objects were still further enlarged so as to include all departments of science. A new organization was effected under the present name, and the first meeting was held at Philadelphia, Sept. 20, 1848. This association is a national one, migratory in its visits, meetings having been held in various cities of the Union and Canada annually, except during the years 1861-1865, when they were suspended in consequence of the unsettled condition of the country. A volume of proceedings has been printed for each of these meetings. President, Prof. Joseph Le Conte, Univ. of Cal., Oakland, Cal.; Permanent Secretary, F. W. 4. **CITY ORPHAN ASYLUM OF SALEM**, No. 215 Lafayette street. Organized 1866. Conducted by twelve Sisters of Charity. Lady Superior, Sister Brazeau. This institution provides a home for orphan boys and girls, who receive a due amount of education in the common branches of learning.

5. **ESSEX INSTITUTE**. This institution was formed by the union of the Essex Historical and Essex County Natural History Societies, in February, 1848. The former Society was incorporated in 1821, the latter in 1836. In February, 1870, an act was passed enlarging the powers of the Institute so as to include among its objects, the promotion of the arts, science and literature, in addition to those of the original societies. Its library contains about 60,000 volumes bound, and about 250,000 pamphlets, exclusive of duplicates, and embracing all departments of literature. Its museum contains a large collection of antiquarian and historical relics, paintings, engravings, medals, coins, paper currency, etc. The scientific portion is deposited in the Museum of the Peabody Academy of Science. At the time of its removal, the collection contained over 125,000 specimens in the departments of Ethnology, Zoology, Botany, Mineralogy, and Geology, scientifically arranged, and in good part labelled and catalogued. Its publications are, the "Proceedings of the Essex Institute," 6 vols.; "The Naturalist," vol. 1 (afterwards transferred to the Peabody Academy of Science); "Bulletin of the Essex Institute," 24 vols., 8 vo.; "Historical Collections of the Essex Institute," 28 vols., 8 vo. The Historical Collections and Bulletin are regularly issued. Field meetings are held in different parts of the county for scientific and historical investigation and discussion. Evening meetings for the same purpose are regularly held during the winter, at

the rooms of the Institute. The Institute also gives courses of scientific and other lectures, and series of concerts during the winter months, and Horticultural and Art exhibitions during the Spring, Summer and Autumn months. The building next east of Plummer Hall, built by the late Tucker Daland, has been purchased by the Essex Institute, and has been remodelled and arranged to accommodate its library and collections. It also occupies the first floor of Plummer Hall, in which is deposited a portion of its library, and where the lectures, meetings and exhibitions are held. Henry Wheatland, President; Abner C. 7. **PEABODY ACADEMY OF SCIENCE**, 161 Essex street. The "Trustees of the Peabody Academy of Science" organized in 1868, having received funds by gift in 1867 from George Peabody of London, for the "Promotion of Science and Useful Knowledge in the County of Essex."

Under the instrument of trust, East India Marine Hall (erected in 1824) was purchased and re-fitted, and the Museum of the East India Marine Society and the Natural History Collections of the Essex Institute (begun in 1834) received by the trustees as permanent deposit were placed therein. To this foundation have been added many valuable collections since received by the trustees. A new exhibition hall was opened in 1889.

The arrangement of the Museum is *educational*, and not merely for the purpose of exhibiting curiosities. It is especially designed to aid the teachers of the county in connection with school work.

The collections in the public exhibition halls may be summarized as follows:

I. A collection of the animals and minerals of Essex County. A collection of woods of the trees of Essex County, and one of the pre-historic relics of the county. A large collection of the dried plants of the county, in cabinets, in the lower rooms, may be consulted by students upon application at the office.

II. A synoptical collection illustrating the animal kingdom, from the lowest to the highest forms, arranged according to

the text-books in common use in our schools and colleges. Letters upon the cases indicate the order in which it should be examined

III. A type collection of minerals illustrating the edition of Dana's Mineralogy, used in our schools.

IV. A collection of objects illustrating the dress, religious customs, implements of war and of domestic use, and objects of art of the native races of China, Japan, India, Korea, Africa, Polynesia, North and South America, etc., in the new east hall. This collection originated in 1799 with the formation of the East India Marine Society, and has had an uninterrupted existence since that date. It was greatly increased in 1868 by the specimens received from the Essex Institute, and large additions have since been made by the Academy trustees.

V. An historical collection of portraits of prominent Salem merchants, members and officers of the East India Marine Society, together with many interesting relics connected with the early social character of that institution, and models and pictures of Salem merchant vessels. These form an interesting memorial of the commercial history of Salem.

The Academy has published two volumes of memoirs and annual reports; it has conducted classes in botany, mineralogy and zoology, and for several years held a summer school of biology. Lectures upon subjects connected with natural history and ethnology are given annually in Academy Hall.

The average number of visitors to the Museum has been over 45,000 annually during the past five years.

The Museum is open *free* to the public, every week-day from 9 A. M. to 5 o'clock P. M., and Sundays from 2 to 5 P. M.

The large addition made to East India Marine Hall, for the purpose of increasing the Museum accommodations, has on the lower floor a fine lecture hall, known as Academy Hall. It has a seating capacity of 350, is centrally located, comfortably seated, well ventilated, and is in every respect a first class audience room. The hall is used for lectures by the Academy, and is rented for concerts, lectures and readings.

The museum offices are on the lower floor of E. I. M. Hall, rear rooms.

S. PLUMMER FARM SCHOOL OF RE-

FORM FOR BOYS. This school was founded by the bequest of Miss Caroline Plummer. It is a school of reform for boys in the city of Salem. The amount of the bequest was \$25,000. Present fund \$50,000. Incorporated May 21, 1855. Building erected in 1870, and the school was opened September 23, 1870. President, William I. Bowditch; Treasurer and Secretary, Gilbert L. Streeter; Superintendent, C. A. Johnson; Assistant Superintendent, C. F. Higgins; Matron and housekeeper, Mrs. C. A. Johnson; Teacher, Harriet R. Higgins; Trustees, William I. Bowditch, Gilbert L. Streeter, Francis Cox, William G. Webb, James Dugan, William H. Jelly, James B. Curwen, George M. Whipple, Edmund B. Willson, T. Frank Hunt. A generous bequest of \$35,000 was left to the school by the will of the late Capt. John Bertram. Number of boys in the school, 30.

9. SALEM ATHENÆUM was incorporated in March, 1810. Its conception was suggested by the Boston Athenæum, organized some three years earlier. The characters of the two institutions are in many respects similar, the incorporated objects of both being the promotion of literature, the arts and sciences. The Salem Athenæum purchased the social and philosophical libraries. The former organized in 1761, the latter in 1781. The Athenæum rooms in Central building, Market (now Central) street, were opened to the proprietors on Wednesday, July 11, 1810, with a good collection of books properly arranged and classified. In April, 1815, the library was removed to rooms in Essex place; in 1825, to rooms over the Salem Bank; in 1841, to Lawrence place, and in 1857 to Plummer Hall. The present number of volumes, about 24,500. Miss Caroline Plummer, daughter of Dr. Joshua and Olive (Lyman) Plummer, born Jan. 13, 1780, and died at Salem May 15, 1854, bequeathed to the proprietors of the Athenæum \$30,000, for the purchasing of land and the erecting thereon a building known as Plummer Hall, in which are deposited the libraries of the Salem Athenæum, Essex So. District Medical, Essex Agricultural Societies, and a portion of the library of the Essex Institute. The Athenæum is managed by trustees, annually chosen by the stock holders; each share holder may take out books upon payment of the annual assessment of five dollars. 12. SALEM EAST INDIA MARINE SOCIETY. Founded in October, 1799. Incorporated in 1801. Membership restricted "to persons who have actually navigated the seas beyond the Cape of Good Hope or Cape Horn." Its chief objects: 1st, to assist the widows and children of deceased members, who may need it, from the funds of the Society; 2nd, to collect such facts and observations as tend to the improvement and security of navigation; 3rd, to form a museum of natural and artificial curiosities, particularly such as are to be found beyond the Cape of Good Hope and Cape Horn. The collections formed were first deposited in the building on the corner of Essex and Washington streets. In 1804 they were removed to the Salem Bank Building, on the site of Downing's Block, and in 1825 to the East India Marine Hall, erected for the accommodation of this valuable collection. In 1867 the building was sold to the Trustees of the Peabody Academy of Science, and the Museum was placed in the hands of the Academy as a permanent deposit. Although no longer conducting the Museum, or making nautical observations, the charitable objects of the society are fully carried out through the means of a fund of considerable amount in possession of the society. Meetings are held quarterly at E. I. Marine Hall. Officers elected annually on first Wednesday in January. President, William G. Webb; Secretary, Nathan A. Bachelder; Treasurer, Nathan H. Millett; Committee of Observation, Edward D.

Ropes, Wm. H. Jelly, Lewis F. Miller; Distributing Committee, George E. Lord, Frederick Johnson.

13. THE SALEM FRATERNITY. On the 7th of February, 1869, Mr. Alfred Stone, of Providence, formerly a resident of Salem, by invitation addressed a meeting at the East Church, explaining the working of the Providence Union. The next evening a few persons came together, in the parlors of Benjamin H. Silsbee, Esq., to confer upon the matter further. Other meetings followed at the same place, and resulted in the formation of the *Salem Fraternity*; object, "to provide evening instruction and amusement" for such of our population as, "being confined to their work during the day, need recreation at the close of their labors." On the evening of the 21st of April, 1869, the western range of rooms on the second floor of Downing's Block, 175 Essex street, was opened for the purpose, from front to rear. *The Amusement Room*.—The numbers in attendance fluctuates with the season, and with the attractions outside. In the warm weather and short evenings a few only will appear. During the long winter evenings, especially if cold and stormy, this comfortable room is much prized. *The Library*.—It began with a few shelves of books, miscellaneous and unselected, in a small, back room. There are now 4221 volumes in the library; 500 for reference only; gathered by gift wholly. It was the first free library in Salem. Its large number of readers shows an active circulation. *The Reading Room* is supplied with the Salem papers by the favor of the publishers, and from some of their offices come, besides, many of their most desirable exchanges; several daily and weekly newspapers, pictorial weeklies, religious, scientific, and literary periodicals, find their way to the tables at a very small outlay of money. In 1875 the Fraternity became incorporated under the Statutes of Massachusetts. 14. SALEM HOSPITAL. Organized April 7, 1873, from a fund contributed by Capt. John Bertram and other citizens. Applications for admission to be made to the superintendent at the hospital, 31 Charter street, between 12 M. and 1 P. M. Open for the reception of visitors on Wednesday of each week, from 2 to 5 P. M. Annual meeting, fourth Wednesday of January. William G. Webb, President.

15. SALEM LYCEUM. Organized Jan. 18, 1830. Lyceum hall erected in 1831. The purchase of a ticket to the annual course of lectures and signing the By-Laws makes a person a member of the corporation, and the price of a ticket has never been more than one dollar. Nathaniel J. Holden, President; Charles C. Rhoades, Vice-President; Edward C. Batis, Secretary; A. Augustus Smith, Treasurer; George P. Woodbury, Nathaniel M. Brown, Leland H. Cole, Charles E. Burns, William D. Chapple, Managers; Caleb Foote, John M. Raymond, Charles S. Osgood, Trustees. Annual courses of lectures have been delivered before the Lyceum without interruption since 1830, and it is the oldest institution of the kind in the country with perhaps one exception.

16. SALEM PUBLIC LIBRARY. On the first of December, 1887, the heirs of Capt. John Bertram offered to the city his late residence on Essex street to be used for the purpose of establishing a Public Library. On the twenty-seventh of December, 1887, the City accepted the gift and instructed its committee to petition the Legislature for authority to issue bonds to the amount of \$25,000 for the use of the library. The library was opened to the public for the delivery of books, July 8, 1889. There are now in the library 25,373 volumes. By the provisions of the deed of gift the management of the library is vested in a board of seven trustees, six to be elected for life by the City Council, and the Mayor of the city for the time being, to be the remaining member, *ex-officio*, and the chairman of the board. The City

Council elected the following named gentlemen as trustees for life: George R. Emmerton, James A. Emmerton, Nathaniel A. Horton, Thomas F. Hunt, Charles S. Osgood, George W. Williams, and these gentlemen with the Mayor constituted the first Board of Trustees. Mr. George R. Emmerton, Dr. James A. Emmerton and Mr. Nathaniel A. Horton, having died since their election, the vacancies have been filled by the election of David Pingree, Jeremiah T. Mahoney and John Robinson. Regular meetings of the trustees are held on the second and fourth Fridays of each month at 5 o'clock, P. M. Organization of the Board: Robert S. Rantoul, Chairman; Charles S. Osgood, Secretary; George W. Williams, Treasurer; Gardner M. Jones, Librarian. The Library is open every day for the delivery of books (Sundays and legal holidays excepted) from 9 A. M. to 8 P. M., on Saturday until 9 P. M. The reading room is open every week day from 9 A. M. to 10 P. M., and on Sunday from 2 P. M. to 8 P. M.

17. SALEM YOUNG MEN'S CHRISTIAN ASSOCIATION, was organized Nov. 17, 1858, in the South Church chapel. Rented rooms were occupied until Sept. 18, 1884, when it removed to its present building on Central street, which it purchased in March of that year. The organization was incorporated Jan. 10, 1884. The annual meeting since November, 1887 has been held the third Wednesday in April. The building is open from 9 A. M. to 9.30 P. M. week days, and men are always welcome. Its equipments consist of an excellent reading room, parlor, hall and gymnasium, boys' room, bath rooms, and kitchen. Evening classes, socials, entertainments, gymnasium, young men's congress, employment bureau, boarding house register, religious services and Bible classes are the means employed in the work. The boys' branch was started in 1869 and is the oldest in the country. William H. Whipple has had charge since its beginning. At the last annual meeting the association had 359 members besides 211 in the Boys' Branch, and 294 in the Woman's Auxiliary, making nearly 900 persons who are directly connected with the organization. The officers and employees are Walter K. Bigelow, president; D. B. Hagar, vice president; W. H. Derby, recording secretary; Samuel J. Foster, treasurer; Ezra L. Woodbury, auditor; Walter B. cultural Society. Colonel Timothy Pickering was chosen the first President, and continued in this office for ten successive years. Incorporated June 12, 1818. Its first exhibition was held at Topsfield, Oct. 5, 1820. These have been continued annually, either in the month of September or October, in several towns or cities in the county, usually twice successively in the same place. This society was the first in the State to publish an annual report of its doings, which has been continued about sixty years. A library was commenced in the autumn of 1849, by the purchase of the library of the late lamented Rev. Henry Colman, numbering five hundred and eighteen volumes. These were first deposited in the City Hall, Salem, the city clerk, Joseph Cloutman, acting as librarian. In 1853 it was removed to the Court House, and in December, 1862, to Plummer Hall. The books circulate among members only. Francis H. Appleton of Peabody, President; J. J. H. Gregory of Marblehead, Oliver S. Butler of Georgetown, James P. King of Peabody, Horatio G. 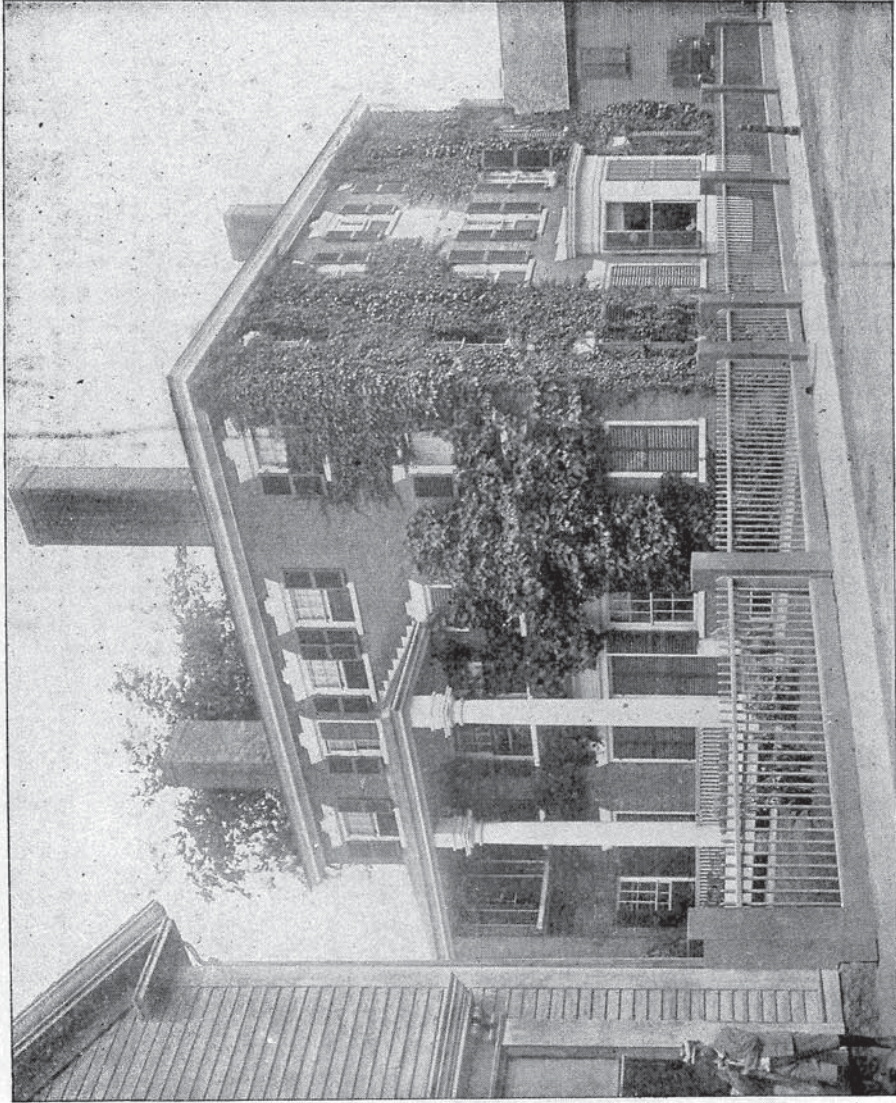

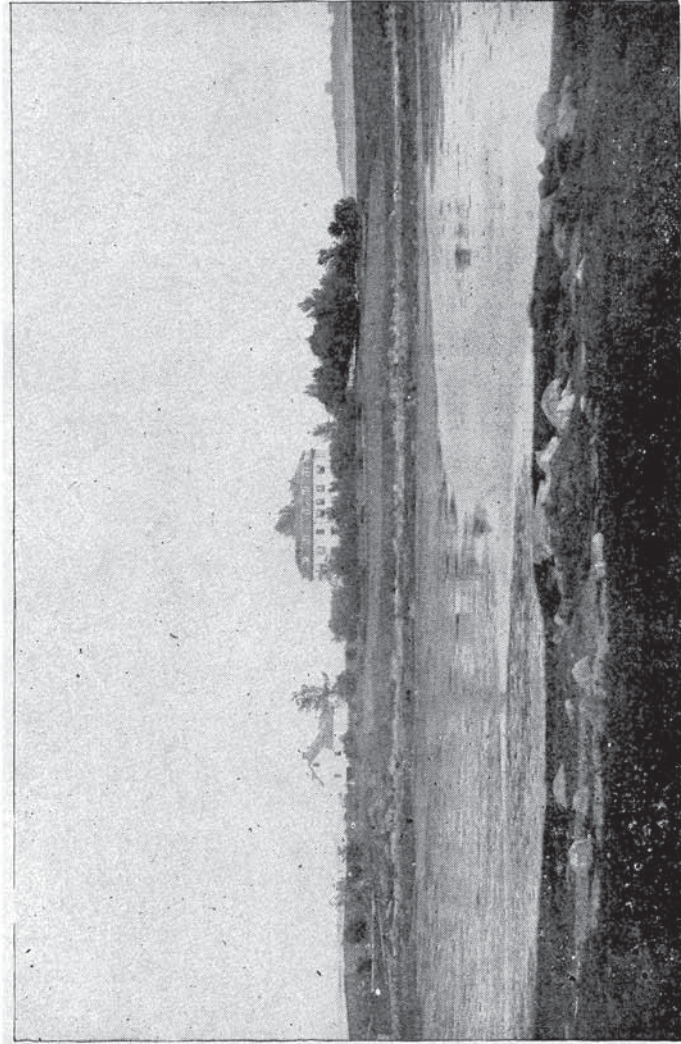

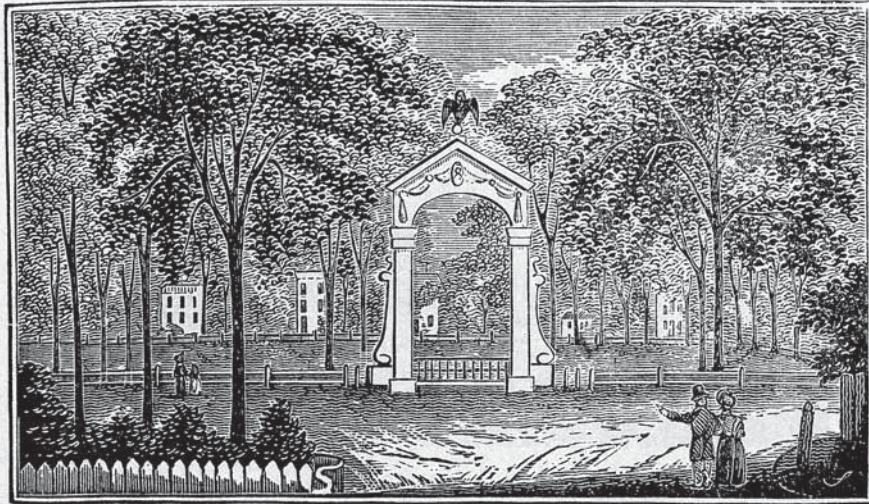




OLD GENTLEMAN'S HOME, SALEM.

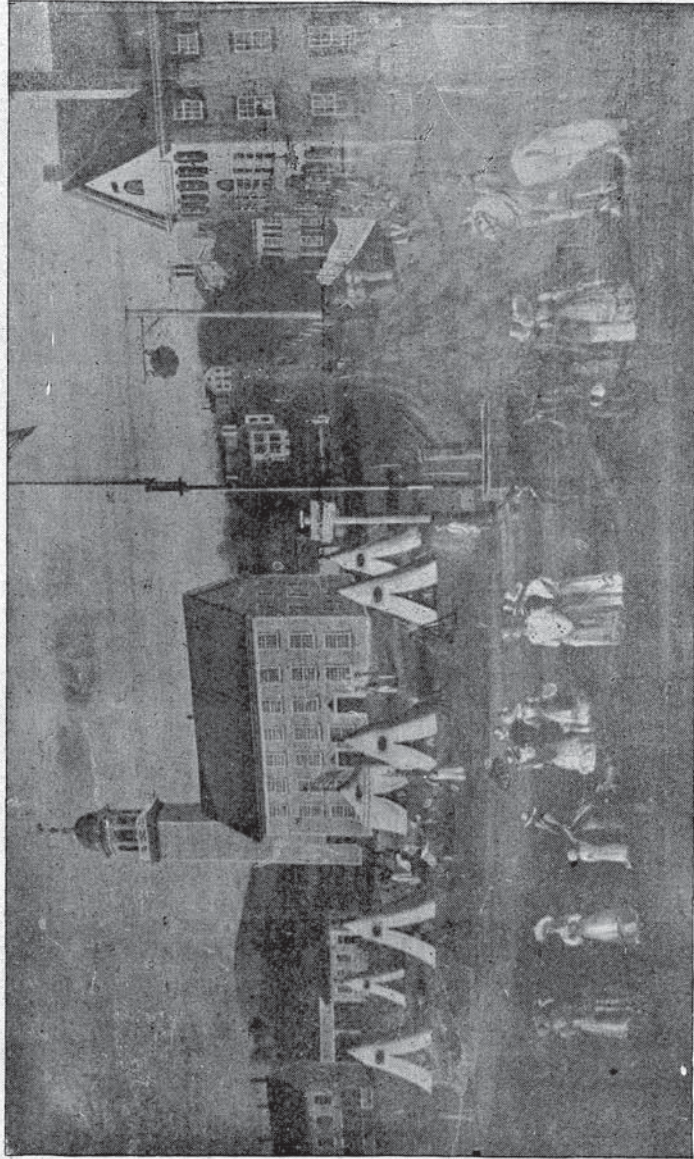

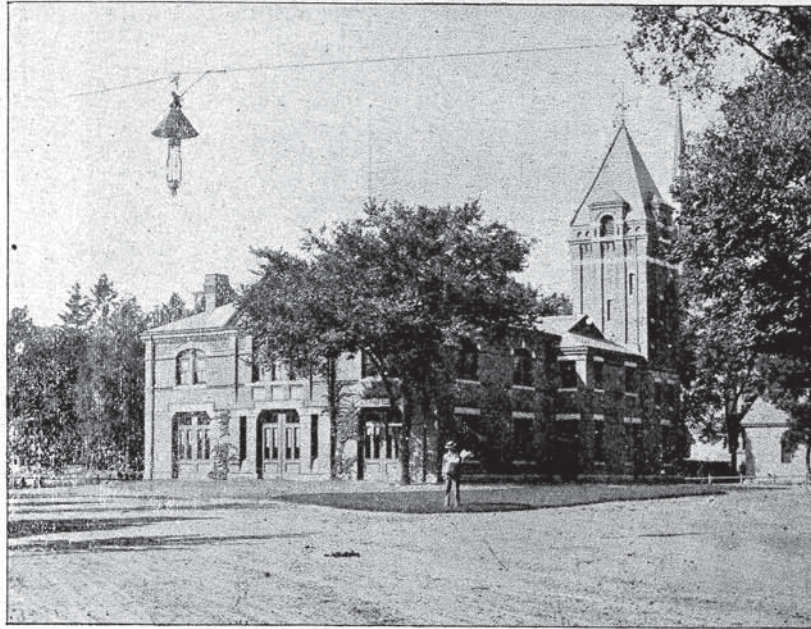
