PLUMMER HALL.

This building is located at 134 Essex street. It was erected in 1856, from funds left by the late Miss Caroline Plummer. The first story contains a portion of the library and the historical collections of the Essex Institute, also periodicals and publications of societies received in exchange. The second story contains some of the principal works of reference, and the new books belonging to the Salem Athenæum; also the libraries of the Essex South District Medical Society, the Essex Agricultural Society, the Salem Athenæum, and the Essex Institute. The libraries of the several societies in the building contain about 55,000 bound volumes, besides a large collection of pamphlets.

The scientific collections have been placed in the East India Marine Hall. Exhibitions of art, also fruits and flowers, are occasionally held at their room at Plummer Hall.
